- This application is for Pantomime Tickets to see **SNOW WHITE at The Aylesbury Waterside Theatre at 2.30pm on SATURDAY, 2 DECEMBER 2023.**
- If your application is successful, The Stoke Mandeville and Other Parishes Charity will provide tickets to all adults and children named on the application form.
- Applications must be submitted by **midnight on Sunday, 10th September 2023 in order to be considered.**
- All applications must include at least one child aged between 3 and 12 years old.
- All children must be accompanied by at least one adult (over 18).
- A maximum of 2 Adults and 4 children per application.
- No group bookings – one family per application.
- All adults must have resided in the parish for 2 or more years. All children must currently reside in the parish.
- Incomplete and spoiled applications will be automatically declined. **Please fill in your application form carefully. Please note that we no longer accepted photographed copies of your application form via email as they are not legible.**
- We cannot acknowledge receipt of your application form due to volume of applications.
- No tickets will be allocated until all applications have been received and the application closing date has passed. In the event of over subscription, a ballot will be drawn.
- The Charity is not responsible for cancellations or changes in the programme by the Aylesbury Waterside Theatre. In this event, no compensation will be available from the Charity.
